Impact of new Covid-19 regulations on faith and belief communities



Following debate in Parliament, new regulations which established a national framework for local restrictions in England have come into force. This brings in three 'tiers' of COVID-19 response level and associated restrictions: Medium, High and Very High.

changes made and what people will want to consider for their places of worship. These are below. These are below.

The FICCRT says "Places of worship remain open for communal prayer at all Local Alert Levels - this is thanks to your continued efforts to ensure your spaces are as safe as possible and adherence to social distancing guidance is maintained. In coming months it is going to be even more important to continue with what you are doing to ensure we control the spread of the virus and keep your congregants safe."

Medium Local Alert Level

This is the baseline level of restriction, and summarises the general "state of play" across England to tackle the spread of COVID-19.

- The "Rule of 6" applies to gatherings outside of household/support bubble groups.
- Places of Worship are able to open for public worship for as many people as they can safely accommodate adhering to social distancing guidelines, and people should not mix outside of their groups of 6. Face coverings must be worn by all in attendance unless they are not able to.
- Wedding ceremonies can take place with up to 15 attendees, this doesn't include anyone working at the event. This is the case for all wedding ceremonies, including faith or belief ceremonies that are not legally binding. Face coverings must be worn by all in attendance except the bride and groom, unless they are not able to.
- Wedding receptions can also take place with up to 15 attendees, in the form of a sit-down meal.
- Funerals can take place with up to 30 attendees.
- Post funeral ceremonies, such as Stone Settings or Wakes, can take place with up to 15 attendees.

High and Very High Local Alert Levels

This establishes additional restrictions where rates of infection of COVID-19 are higher.

- For the purposes of Places of Worship and faith or belief groups, the restrictions outlined at both high and very high have the same effect.
- The "Rule of 6" no longer applies, and any mixing outside of households/support bubbles is not allowed.
- Places of Worship can remain open for public worship, for as many people as they can safely accommodate adhering to social distancing guidelines. People should not mix outside of their own households/support bubbles. Face coverings must be worn.
- All wedding ceremonies can continue to take place with up to 15 attendees. Face coverings must be worn by all except the bridge and groom.
- In High COVID Local Alert Level Areas: Wedding receptions can take place with up to 15 attendees, in the form of a sit-down meal.
- Funerals can continue to take place with up to 30 attendees.
- Post-funeral ceremonies can continue to take place with up to 15 attendees.
- In Very High COVID Local Alert Level Areas only: Wedding receptions can no longer take place in any form.

The regulations also allow a local authority to impose tighter restrictions in their areas to limit the transmission of COVID-19. While a Local Authority will have the power to close any venue it considers to be an imminent threat to public health, including a Place of Worship, it will not otherwise be able to vary the rules that now apply to the use of a Place of Worship. However, it is recommended that individual venues continue to work closely with local authorities and consider whether further measures could be brought in to control the transmission of the virus.

Officials note that the Department has worked across-Whitehall to ensure that all weddings are treated equally whether or not they are legally binding. Those who officiate or undertake faith or belief ceremonies without legal recognition are still strongly encouraged to register their marriage as soon as possible before or after the faith or belief ceremony.

App it to zap it: download the NHS COVID-19 app

The new NHS app allows you to report symptoms, check-in to venues by scanning a QR code, provides a symptom checker and can alert individuals that may have coronavirus, book a test and a self-isolation count-down. During this period, the UK experienced various stages of lockdown which undoubtedly created a unique environment that none of us has seen in our lifetimes. Despite the lockdown, many vulnerable individuals were still being held in exploitative situations and this report seeks to provide an understanding of the impact of the pandemic on those contacting the Helpline for advice and support.

Unseen have produced a report, which provides an overview of the nature and scale of contacts to the Modern Slavery Helpline for the six-month period between 23 March 2020 and 23 September 2020.

CAF Resilience Fund

The CAF Resilience Fund is a major new fund distributing more of the £750M originally promised by the government. Grants are from £10k - £100k and must be spent by 31st March

SPORT ENGLAND Launch RETURN TO PLAY OPEN FUND

Sport England have announced the opening of a £16.5m Return to Play Fund.

There are three parts to this new fund - Small Grants, Community Asset and Active Together crowdfunding - with all three focusing on a safe return to play and narrowing the inequalities gap in sport and physical activity. The fund is to support the Return to Play during the Autumn and Winter. This is a rolling fund with no specific deadline. Groups that received Emergency Funding or Tackling Inequalities

Funding previously from Sport England can still apply. It will include Lottery and Exchequer funding to accommodate religious groups. The fund will be competitive, with priority given to organisations working in areas classed as 1-3 from the Indices of Multiple Deprivation (IMD) (enter your delivery postcode <u>here</u> to find out what decile you're in) and those working with key beneficiary groups such as BAME and Disability.


