Afghan Refugees in Surrey

Agencies across Surrey are currently helping with the repatriation of Afghan migrants to the UK. Surrey is a welcoming county, and several local boroughs have already opened their doors to help house individuals and families fleeing to the UK. Surrey County Council is also working closely with District and Boroughs, health providers, the voluntary and charity sector, other local partners and central government to ensure families can be resettled safely.

While the immediate need is to find accommodation to house people once they have completed their stay through Managed Quarantine Service hotels, there are wider needs to be considered, including health, social integration and basic supplies.

Our communities stand ready to support this effort and many Surrey residents are asking if they can help. Due to operational and logistical challenges, as well as COVID control considerations, we are asking that any donations at this point are financial ones, to charities that are best equipped to immediately support Afghan refugees. The Community Foundation for Surrey is set up to administer these donations locally and information on how to donate can be found on their website.

Alternatively, the <u>Red Cross</u> are already active in managing donations and supporting arrivals from Afghanistan, and wider local support will be needed from foodbanks and other charities, which can be found via <u>Surrey Information Point</u>.

COVID-19 and safe use of places of worship

On 19 July England moved to Step 4 of the 'roadmap'. There are no longer legal requirements for physical social distancing or the wearing of face masks in indoor spaces. However, the UK Government has emphasised that COVID-19 remains a serious health risk and that it is important to remain cautious to help protect one another. There are no longer legal limits on the number of people who can attend weddings, funerals and other life events or the receptions that follow. All restrictions on chanting and singing have also been removed.

Near Neighbours Network

The Near Neighbours Network is a new opportunity for individuals and organisations to connect with other likeminded people and groups beyond the 11 Near Neighbours areas in England. Near Neighbours notes: "We remain committed to creating strong and cohesive communities at local level, but we also want to create a wider national network where all the groups and individuals involved with Near Neighbours can share good practice and expertise and build new partnerships. The Network will also enable our hubs and partners to offer knowledge and training, online events, and downloadable resources, to a wider audience."

Surrey Launches New Greener Transport Plan

Earlier this month, <u>Surrey County Council</u> launched a three month consultation on <u>Surrey's new Transport</u> Plan which includes plans to reduce the 46% of carbon emissions currently generated by transport.

Proposals include increasing walking and cycling routes to encourage people out of their cars, providing more charging points and parking for electric vehicles, more bus services, charging for transport use and introducing car clubs, as well as improving internet connections for home-working and redesigning neighbourhoods that enable easier access to local services, lessening the need to travel by car.

Hate Crime

Hate crime Home Office data released in July shows that a total of 61,851 racially and religiously aggravated offences were recorded in 2020, a 7% increase on 2019. The analysis was compiled by the PA news agency from data published by the Home Office and can be found here.

CST's Antisemitic Incidents Report January-June 2021, published on 5 August, shows 1,308 anti-Jewish hate incidents nationwide recorded by CST in the first half of this year. This is a 49% increase on incidents recorded in the first six months of 2020, and is the highest total CST has ever recorded in the first half of any year. The number for this 6 months is higher than every full-year incident total prior to 2016 since CST began recording antisemitic incidents in 1984.

Tell Mama's recent reports on Islamophobic incidents include graffiti in Northumberland.

A <u>report on the Public Inquiry</u> into Islamophobia in Scotland by the Cross-Party Group on Tackling Islamophobia, published by Newcastle University, speaks of increasing verbal and physical assaults on Muslims.

As well as antisemitic and Islamophobic incidents, other communities continue to express concerns about incidents. In a response of 10 June from Minister for Regional Growth and Local Government Luke Hall to a Written Question from Navendu Mishra MP about tackling Hinduphobia, the Minister referred to "the refreshing by the Government of its hate crime strategy."

<u>An Early Day Motion</u> was tabled on 23 June which condemned racism faced by British Indians and made reference to "research by the 1928 Institute which revealed that 80 per cent of British Indians have faced prejudice because of their Indian identity, with Hinduphobia the most prevalent".

Holocaust Memorial and Learning Centre

Planning permission was granted by the Government on 29 July to build the country's first national Holocaust Memorial and Learning Centre in Victoria Tower Gardens, next to Parliament. The Memorial will be the national focal point to honour the 6 million Jewish men, women and children who were murdered in the Holocaust, and other victims of Nazi persecution, including the Roma, gay and disabled people.



The co-located Learning Centre will also focus on subsequent genocides in Cambodia, Rwanda, Bosnia and Darfur.

Faith communities, climate change and the environment

The 26th <u>UN Climate Change Conference of the Parties (COP26)</u> is scheduled to take place in Glasgow from 1-12 November.

It will bring parties together to accelerate action towards the goals of the Paris Agreement and the UN Framework Convention on Climate Change.

Together with the Environmental Issues Network of Churches Together in Britain and Ireland, Faith for the Climate convenes a COP Faith Task Group called 'Make COP Count' to enable diverse faith groups to contribute meaningfully to climate action before, during and after COP26. Its priorities are: Transformation; Advocacy; and Hospitality. More information here

Among the activities it is supporting are:

- Climate Sunday An initiative led by CTBI, which encourages the holding of a climate-focused worship service any time before COP26, and which will culminate in a Nations Climate Sunday service on 5
 September. A number of Churches have created downloadable resources for this initiative.
- Rise to the Moment A relay pilgrimage from St Ives to Glasgow, organised by the Young Christian Climate Network. This is a relay rather than a full pilgrimage because of the restrictions on gathering in person. The relay enables people to take part in different ways. It is taking place through August, September and October

Inter Faith Buddies

Inter Faith Buddies is a scheme designed by Interfaith Network UK to bring individuals together to engage in dialogue.

- The scheme involves two people of different faiths or beliefs: keeping in touch on a weekly basis for 6 weeks;
- choosing or developing questions on which to share their thoughts and experiences; and
- if they wish, sharing at an in-person or online event, in an agreed way, some reflections on what they have gained from the experience.

It is an opportunity for sharing and learning, on a one-to-one basis across a limited period of time, about what is important to us, in the context of our wider community. The process may, of course, lead to longer term conversations and new forms of practical co-operation.

Faith Communities and Covid-19: Learning from the Journey

The Interfaith Network UK held a national meeting earlier this year, which explored a wide range of issues. These included how places of worship had coped with periods of closure and with social distancing; health care chaplaincy and the handling of funerals and bereavement; and responding to loneliness and domestic abuse during the pandemic. It heard from faith communities with high BAME membership responding to the disproportionate impact of COVID-19 on them and about initiatives to address vaccine hesitancy. The gathering also considered how digital communication has been being used for inter faith dialogue and cooperation and the future possibilities of that; how faith communities, local authorities and other statutory agencies have been working in partnership; how schools have adapted during the pandemic and a new IFN teacher resource to help 11-14 year olds learn about inter faith activity, with examples from inter faith responses to the pandemic; the financial impact of the pandemic on faith community organisations; how the pandemic experience is being captured through research; and the practicalities of standing in solidarity and issuing statements.

Supermarket Voucher Hardship Scheme

The Diocese of Arundel and Brighton has obtained a grant from the Albert Gubay Foundation to provide free supermarket food vouchers for people in need. The scheme has helped over 2,500 families so far, though there are still vouchers for Sainsbury's, Tesco, Asda and Morrison's available for our parishes and schools to distribute to those in need.

Breathing Space

The new Government scheme "Breathing Space" gives you temporary protection from most types of debt collection, while you work with a debt adviser to take action to get on top of your finances. You can be protected from creditors for 60 days, with most interest and penalty charges frozen and enforcement action halted. Certain types of payments including ongoing housing costs, utility bills and taxes will still need to be paid during this time. Listed Places of Worship grant scheme

The Listed Places of Worship (LPW) Grant Scheme gives grants that cover the VAT incurred in making repairs to listed buildings in use as places of worship. The scheme covers repairs to the fabric of the building, along with associated professional fees, plus repairs to turret clocks, pews, bells and pipe organs. The Grant Scheme is run by the Department for Digital, Culture, Media and Sport and administered by Topmark.

The Changing Face of Nursing: Black Nurses in Surrey Hospitals A talk for Black History Month by Dr Catherine Babikian

1 October, 5.30pm to 6.45pm

From its launch, the National Health Service relied on the labour of thousands of nurses, doctors, and health care workers from overseas. Surrey hospitals were no exception. For Black History Month, this talk draws on the Surrey History Centre's rich health care collections to explore the experiences of Black nurses in Surrey. The talk will begin with some framing context for how and why Black nurses from the Caribbean and Africa came to staff the NHS, before diving into the archives of Surrey hospitals such as West Park Hospital, Epsom, and Netherne Hospital, Coulsdon.

Dr Catherine Babikian is an historian interested in the relationship between migration and health care. Her PhD thesis examined the history of overseas nurses in the NHS and the impact of nurse migration on Britain and its former colonies.

Wellbeing workshops promote positive, emotional and mental wellbeing through six everyday actions

<u>Connect 5</u> – Ways to work with Mental Wellbeing in everyday practise. This course will enable people to have conversations about mental health and offer information on local service. Connect 5 is aimed at everyone.

<u>SafeTALK</u> - half-day alertness training that prepares anyone 15 or older, regardless of prior experience or training, to become suicide-alert.

Applied Suicide Intervention Skills Training (ASIST) is a two-day interactive workshop in suicide first aid.
